





Appendix no. 5. Terms and Conditions of the FRSE Publishing House Monographs Programme

The Foundation for the Development of the Education System implements the FRSE Publishing House Monographs programme, under which it finances the publication of peer-reviewed works on education in the humanities and social sciences (hereinafter: "Works" or "Monographs"). These Terms and Conditions (hereinafter: "Terms and Conditions") set out the rules for the implementation of the programme.

GENERAL PROVISIONS

§ 1

- 1. The FRSE Publishing House Monographs programme is implemented under the rules of the contest (hereinafter: "Contest").
- 2. The organiser of the Contest is the Foundation for the Development of the Education System (hereinafter: "Organiser" or "FRSE"), represented by the Director of the Research and Publishing Unit, and the body responsible for the substantive side of the Contest is the Scientific Council (hereinafter: "Contest Jury"), appointed by the Director General of the Foundation for the Development of the Education System.
- 3. The number of monographs to be published in a given edition of the programme, the schedule of the Contest and the amount of possible fees in a given year are announced each time in the Contest Announcement.
- 4. The condition for publishing the Monograph is successful completion of the following procedures: preliminary evaluation, substantive evaluation and external review, signing the Licence on the transfer of copyrights in the works included in the Monograph to the Organiser, and agreeing the final content of the Work or its fragments with the editors of the FRSE Research and Publishing Unit.
- 5. Monographs published as a result of the Contest are covered by Creative Commons Licenses (BY-4.0 Attribution).
- 6. The works awarded in the Contest will be published in the "Monographs" series in Polish and English.
- 7. The Contest is conducted under the rules set out in the Terms and Conditions and in accordance with generally applicable laws. By submitting a Work to the Contest, the Applicants accept the Terms and Conditions.
- 8. Applicants will be notified electronically of the results of the Contest and of the various stages of evaluation. The list of winners of the Contest will be made public on the FRSE website (www.frse.org.pl).

PURPOSE AND PROCEDURE OF THE CONTEST

§ 2

1. The purpose of the Contest is to select and publish peer-reviewed, previously unpublished monographs in the humanities and social sciences, concerning education in the broad sense of the term, and characterised by a high level of scientific excellence.

- 2. Works that most closely meet the preliminary and substantive criteria specified in § 5 of the Terms and Conditions will be submitted for publication.
- 3. The Organiser reserves the right not to award prizes or to award fewer prizes than indicated in the Contest Announcement if the Works submitted do not meet the preliminary criteria or receive a low score during the substantive evaluation.
- 4. In the case referred to in sec. 3, the Organiser may announce a second round of the Contest in a given year, which will be conducted under the same rules.

CONDITIONS FOR PARTICIPATION IN THE CONTEST

§ 3

- 1. Scientific works that comply with the definition included in § 10(1) of the Regulation of the Minister of Science and Higher Education of 22 February 2019 on the Evaluation of the Quality of Scientific Activities may be submitted to the FRSE Publishing House Monographs programme.
- 2. Monographs may constitute a work written by a single Author, a team of Authors or under the direction of a Scientific Editor(s) (hereinafter: "Applicant").
- 3. The content of the Work should concern a selected area of education supported by the Organiser within the disciplines of the humanities, social sciences, or through an interdisciplinary approach. These areas include: higher education, school education, vocational education and training, adult education, non-formal youth education, language education, mobility of educational staff, mobility of learners, cooperation of institutions aimed at improving the quality of the education system. The way in which the topic is framed is free.
- 4. Contest Works may not include works commissioned by the Contest Organiser prior to the announcement of the Contest or works already published.
- 5. The authors or co-authors of the Works may not be members of the Contest Jury or their immediate family members (spouses, ascendants, descendants, siblings, persons in the same line or degree of affinity, persons in an adoptive relationship), persons in a cohabiting relationship.
- 6. Unpublished doctoral dissertations, publications prepared within the framework of ongoing research grants, prepared as part of individual research interests or as part of other professional tasks at a research and development units may also be submitted to the Contest.
- 7. Master's theses will be accepted for evaluation provided that they are accompanied by a recommendation justifying the scientific or research value of the thesis, prepared by a specialist with a degree or title in the field to which the Work relates. The author of the recommendation cannot be a thesis supervisor, a reviewer of the defended thesis, a member of the Contest Jury or a person connected with the Author of the submission by family, private, institutional or professional relations.
- 8. A defended unpublished thesis may be submitted after the expiry of the publication priority period specified in Article 15a of the Act of 4 February 1994 on Copyright and Related Rights (as amended).
 - 9. Submissions that do not meet the conditions set out above will not be considered.

METHOD OF SUBMISSION

§ 4

- 1. In order to submit a Work, all Authors and Scientific Editors have to individually and correctly fill in the electronic form available in the Contest section of the Publishing House page on the FRSE website. Persons participating in the Contest may not authorise third parties to perform this task.
- 2. The form contains the following sections:
 - a. Information on the Submitted Work to be filled in by the Author of the Work, the Scientific Editor (in the case of multi-author publications) or one of the Authors (in the case of collective publications) designated to contact the Organiser (the contents of this section are made available for information purposes in Annex 1 to the Terms and Conditions);
 - b. Statement of Text Originality to be filled in by the Authors/Co-authors of all texts included in the Work and by the Scientific Editor (Annex 2 to the Terms and Conditions);
 - c. Information on the processing of personal data of Participants of the FRSE Publishing House Monographs programme to be filled in by the Authors/Co-authors of all texts included in the Work and by the Scientific Editor (Annex 3 to the Terms and Conditions);
 - d. an electronic version of the Work in Polish or English, prepared in compliance with the Technical Standards for Publications Submitted to the FRSE Research and Publishing Unit

 Appendix no. 4 to the FRSE Research and Publishing Unit Work Instructions (hereinafter: "Technical Standards").
- 3. The documents submitted to the Contest (in particular the Works) may be prepared in Polish or English, unless otherwise specified in the Contest Announcement.
- 4. Contest entries and annexes are not subject to return. The duration of their storage and method of deletion are subject to the rules in force at the Foundation for the Development of the Education System.
- 5. The deadline for the submission of Contest Works is specified in the Contest Announcement and made available on the Publishing House page on the FRSE website.
- 6. The date of submission of the Work to the Contest is the date of receiving legible and complete documentation meeting the requirements set out in sec. 2.
- 7. Submissions of Works made after the deadline will not be considered and will not take part in the Contest.

CONTEST JURY AND EVALUATION CRITERIA

§ 5

- 1. The process of evaluating the Contest Works includes the following procedures: preliminary evaluation, substantive evaluation and external review.
- 2. The preliminary evaluation is conducted by the Research and Publishing Unit and approved by its Director. The basis for this is the Preliminary Evaluation Sheet for Contest Works,

constituting Annex 4 to the Terms and Conditions. The sheet may be in the electronic form. The evaluation is based on meeting/not meeting a criterion.

- 3. The following elements are subject to preliminary evaluation:
 - a. originality of the Work verified by an anti-plagiarism software, it must not detect a percentage of borrowings exceeding 15% of the volume,
 - compliance with the conditions for participation in the Contest (criteria specified in § 3 of the Terms and Conditions),
 - c. date of receipt of the Contest documents (specified in the Contest Announcement),
 - d. completeness of the required Contest documents (§ 4(2) of the Terms and Conditions),
 - e. preparation of the Work in compliance with the Technical Standards (Appendix No. 4).
- 4. If there are numerous information deficiencies or deviations from the Technical Standards in the documentation, or if the originality check reveals a percentage of borrowings exceeding 15% of the volume of the Work, the Organiser may dismiss the Work at the preliminary evaluation stage.
- 5. If, at the preliminary evaluation stage, minor information deficiencies or deviations from the Technical Standards are found in the documentation, the Foundation may, within 10 working days from the date of the submission of the Work, request the Applicant to supplement the documentation. If the supplementation is submitted within 10 working days of being informed of the need for supplementation, the Work is deemed to have been submitted by the submission deadline specified in the Contest Announcement.
- 6. The substantive evaluation of the works is conducted by the Contest Jury. It is composed of: a representative of the Organiser and members of the Scientific Council of FRSE Publishing House. The composition of the Jury will be announced on the Publishing House page on the FRSE website.
- 7. The meetings of the Contest Jury are convened by the Organiser. Minutes of the Jury meetings are drawn up by the Secretary of the Contest Jury. The Jury may adopt working regulations.
- 8. The basis for the substantive evaluation is the Substantive Evaluation Sheet for Contest Works, constituting Annex 5 to the Terms and Conditions. The sheet may be in the electronic form.
- 9. Members of the Contest Jury conduct the substantive evaluation according to the following criteria:
 - a. approach to the topic is consistent with the aims and education areas supported by the Organiser,
 - b. assumptions are exploratory and results are relevant;
 - c. methodology is chosen correctly;
 - d. approach is innovative;
 - e. subject matter and form are coherent;
 - f. Work brings value to the development of scientific theory or research practice,
 - g. Work brings value to the development of the education system or to social development.
- 10. For meeting each of the criteria described in sec. 9, the members of the Jury will award points to the Work on a scale from 1 to 6. One member of the Jury can award a maximum of 42 points to a Work.
- 11. The Contest Jury may defer awarding points and ask the Author(s) of the Work to submit corrections within 10 working days.

- 12. The substantive evaluation is concluded by drawing up a ranking list of the Contest Works, based on average points awarded in the individual evaluations of the members of the Jury.
- 13. The highest ranked works are forwarded to two independent external reviewers. The reviewing process is described in the Procedure for Reviewing Monographs Submitted for Publication by the FRSE Publishing Unit (Appendix No. 6 to the FRSE Research and Publishing Unit Work Instructions) and made available on the Publishing House page on the FRSE website.
- 14. In the event that two or more Works receive an equal number of points, rendering it impossible to select the number of Works for the next stage as specified in the Contest Announcement, the Organiser may decide to increase the number of prizes to be awarded.
- 15. The Contest Jury monitors the reviewing process. In cases of contradictory conclusions of external reviews, failure to obtain a recommendation from one of the Reviewers to publish a revised Work following the reviews, or in other contentious cases, the Jury proposes a course of action following the principles of the Committee on Publication Ethics (COPE).
- 16. The completed Evaluation Sheets for Contest Works are not made public.
- 17. The winners of the Contest are the Authors and Scientific Editors of the Works that successfully pass the external review process described in the Procedure for Reviewing Monographs Submitted for Publication by the FRSE Publishing Unit.

CONTEST PRIZES

§ 6

- 1. The Contest prize is the publication of the monograph in printed or electronic form and its promotion via the Internet and at events organised by the Foundation for the Development of the Education System. The costs of reviewing, publishing and disseminating the Works will be covered by the Organiser.
- 2. An additional prize is the translation of the monograph into English (in the case of Works in Polish) or into Polish (in the case of Works in English). The translations will be published by the FRSE Publishing House.
- 3. The Organiser may award fees to the Authors and Scientific Editors of the submitted works, unless otherwise stated in the Contest Announcement.
- 4. In justified cases, the Organiser, having consulted the Scientific Council of FRSE Publishing House, may propose to the Author or Scientific Editor of the Work not awarded in the Contest to publish it outside the FRSE Monographs Series. Such cooperation is established under separate rules.
- 5. Works submitted to the Contest and not selected for publication in any publishing series are not returned to the authors or used for other purposes by the Organiser, and the authors retain full moral and economic rights to the Work.

TERMS AND SCOPE OF THE AGREEMENT

§ 7

- 1. Once the results of the Contest have been announced, the Authors/Scientific Editors of the selected Works shall send signed Statements of Text Originality and Information on the processing of personal data in order to start the publication process.
- 2. The Foundation for the Development of the Education System concludes:
 - a. in the case of individual and collective works: a licensing agreement by the Author/ Co-Author of the Work, specifying their obligations, deadlines, as well as the extent of the granted rights to use the work and the amount of a possible fee;
 - b. in the case of multi-author monographs:
 - i. An agreement with the Scientific Editor of the Work specifying, inter alia, duties of the Scientific Editor, deadlines, as well as the amount of a possible fee;
 - ii. Agreements with the authors of individual chapters, specifying the terms and conditions of cooperation as regards the preparation of excerpts of the Work of their authorship for publication, the principles of copyright exploitation, the amount and conditions of payment of a possible fee.
- 3. The Authors are obliged to license the Work to FRSE for:
 - a. publishing and distributing the Work in the fields of exploitation specified in the Licences,
 - b. distribution and use of the Work or its fragments for advertising or promotional purposes.
- 4. Model agreements referred to in sec. 2 are made available by the Organiser upon request of the interested party.

PUBLISHING CYCLE

§ 8

- 1. The Organiser provides the authors of the selected Works with full editorial and proofreading services as well as translation, typesetting, printing and distribution to the extent indicated in the licensing agreement.
- 2. The procedure for working on a text is described in the Publishing Procedures for Scientific Monographs (Appendix No. 7 to the FRSE Research and Publishing Unit Work Instructions).
- 3. The Research and Publishing Unit agrees with the Author(s) of the chapters (Scientific Editor) on the extent of editorial changes, corrections and additions necessary for the publication of the Work.
- 4. The Authors (Scientific Editors) are required to closely cooperate during the preparation of the translation and the final editing of the Work, in particular in adapting the editorial form to the requirements of the FRSE Research and Publishing Unit within the deadlines specified in the licensing agreement.
- 5. Any disputes concerning the final form of the work are submitted to the Scientific Council of the Publishing House, which proposes the way in which they should be resolved.

6. In the event that the Author(s) (Scientific Editor) does not agree with the proposed solution, the Organiser has the right not to accept the Work or a chapter in the Work, which will result in refusal to conclude / termination of the concluded licensing agreements.

RIGHTS AND OBLIGATIONS

§ 9

- 1. The Author(s) and Scientific Editor(s) declare that they hold the moral and economic rights to the works composing the Work, and that they do not infringe any moral or economic rights of third parties, and in the case of use in fragments of other works already distributed, the Author(s) assure that this has occurred within the permitted scope in accordance with Article 29 of the Act of 4 February 1994 on Copyright and Related Rights (Dz. U. of 2006, No. 90, item 631 as amended) or with the consent of its Author, if the scope of use exceeds the permitted use.
- 2. The Author/Scientific Editor of the submitted Work is fully liable towards the Organiser and third parties should the Work infringe the rights, in particular the copyrights and personality rights of third parties.
- 3. Authors/Scientific Editors are obliged to participate in promotional and publicity events organised by FRSE to a mutually agreed extent.

PERSONAL DATA

§ 10

- 1. The Authors of the submitted Works consent to the storage and processing of their personal data for the purposes of the Contest, in accordance with the Act of 10 May 2018 on the Protection of Personal Data (Dz. U. of 2019, item 1781).
- 2. Detailed regulations on how personal data will be processed for the purposes of the Contest are included in Annex 3.

FINAL PROVISIONS

§ 11

- 1. The Organiser is not liable for events that prevent or significantly impede the proper conduct of the Contest, in particular in the event of fortuitous events, epidemics, restrictions imposed by public authorities, force majeure.
- 2. The Organiser reserves the right to change the provisions of the Terms and Conditions. Changes to the Terms and Conditions will be made public on the Organiser's website.
- 3. The Contest is not subject to the provisions of the Act of 29 July 1992 on Games and Mutual Wagering (Dz. U. of 2004, No. 4, item 27 as amended).
- 4. The Organiser is not liable for any claims of third parties resulting from the infringement of intellectual property rights, including the failure to comply with the provisions of the Act of 4 February 1994 on Copyright and Related Rights (Dz. U. of 2006, No. 90, item 631 as amended).
- 5. In the event that the Author(s) or Scientific Editor is found to violate the provisions of the Terms and Conditions, the Organiser may exclude them from participating in the Contest or terminate their licensing agreements.

Dear Sir/Madam,

In relation to the submission of your text to the FRSE Publishing House Scientific Monographs programme, we would like to inform you that:

- 1. The Foundation for the Development of the Education System is the Data Controller of your personal data.
- 2. Your personal data will be processed in order to ensure your participation in the event described above.

Data is processed in accordance with Article 6(1)(b) and (f) of the General Data Protection Regulation of 27 April 2016 (GDPR), and with Article 5(c) of the Regulation 2018/1725 in the case of information transmitted to the European Commission as part of programmes managed by the European Commission and its agencies.
- 9. You have the right to:
 - obtain information about the processed data, including the categories of processed data and possible recipients of data,
 - require the rectification of incorrect Data or have incomplete personal data completed,
