# ***YOUTH MAINSTREAMING?***

- ➔ Cross-sectoral cooperation and coordination among sectors and policies
- ➔ It means breaking up silo thinking and acting on it but WITH youth involvement and participation

# HOW?

- ➡ Horizontal and far-reaching EU youth strategy with the strong EU Youth Coordinator at the EU level/scaling up the role of the Youth Coordinator
- ➡ EU youth strategy which is at the same time flexible to accommodate young people's changing concerns and needs (able to adapt)
- ➡ Scaling-up and building on existing solutions and structures and success stories, such as the European Year of Youth or the EU Youth Dialogue
- ➡ Financing activities for young people under EU programmes and other instruments that are not directly dedicated to youth
- ➡ "Pushing" others (DGs, ministries, institutions, organisations) and making them aware about young people needs and expectations
- ➡ Aiming at meaningful youth dialogue by introducing quality criteria for youth consultation and sharing them with others

# ***WAYS OF COLLABORATION BETWEEN MEMBER STATES AND EU INSTITUTIONS?***

- ➡ Use the EU Youth Dialogue as an example
- ➡ Exchange of best practices as a way of supporting each other in the process of youth mainstreaming
- ➡ EU youth coordinator and national youth coordinators to strengthen the impact
- ➡ EU Youth strategy needs to be implemented at the same time at EU level and national level
- ➡ Strengthen Youth Policy Dialogues by involving other EU and national institutions in this process

## ***HOW TO BETTER IMPLEMENT EU YOUTH DIALOGUE RECOMMENDATION?***

- ➔ Better communicate the EU Youth Dialogue and make it more visible
- ➔ Impact is there but it is not so visible. It needs to be better presented and explained
- ➔ Recommendations must be more concrete, focused, on-point and targeted to relevant decision-makers
