

Youth Participation Strategy, 2020

Throughout 2024 participatory research on lessons learned in different cases of involving young people in decision-making in National Agencies and SALTO PI has been researched, including the institutional perspective and the opinion of young people themselves

Who was involved

3 Co-researchers –

- Received training on how to interview
- Supported in designing interview guidelines
- Conducted interviews
- Contributed to the final paper
- Presented the research

How was this research conducted

- Exploring 5 different cases of youth involvement in decision-making of institutions
- 16 interviews (with direct coordinators and management representatives)
- 6 interviews with young people involved in cases
- workshop to discuss the results



Some of the challenges identified

- Busyness of everyone involved
- Expectation for the youth involvement to be voluntary
- Difficulties in implementing changes across Agency
- Structural constraints (in recruitment, remuneration)
- Lack of trust (due to experiences of tokenism)

Potential solutions


- Creative a safe and supportive environment
- Caring attitude from the professionals
- Flexibility and usage of both physical and virtual spaces
- Developing small-scale youth involvement mechanisms, trying out
- Considering the diversity of participants and barriers they face
- Focusing on implementing young people's ideas in the Agency and beyond
